Ch. Kuznik reported the call volume increasing throughout the response area. Projections indicate there will be over 17,000 calls for 2022. Incident report – District has had a 22% increase in calls year-to-date compared to 2021. No fire calls in the district in November.

UC Health has transported 10k patients since beginning its partnership with Greeley. The contract originally called for 5 ambulances in the system, and they now have 10 on duty during high call volume times.

Office of Emergency Management – Charlie McCartin resigned on 12/2; Lt. Dom Tatti will serve in the interim role during most of 2023. The City is reviewing the position. The goal is to fill the positions in 2023.
